- Cathedral School has budgeted **\$30,000** to provide Tuition Assistance to K - 8 families.
- Cathedral School has Scholarship funds to honor and assist families that actively participate in our Superior Catholics parish cluster and/or St. Francis Xavier, who wish for their children to attend Cathedral School.
- Cathedral School's intent is to **not** turn away a family solely due to an inability to pay full tuition.
- Tuition Assistance applications are open to parents of all income levels and faiths, though there are guidelines that are followed which determine the amount awarded.
- Families must complete and return all of the following forms to be considered for any tuition assistance or scholarship funding: K-8 Tuition Contract, SCRIP Agreement, and Youth Image & Recording forms.
- Family accounts must be in good standing. If your Cathedral School family account is past due with outstanding balances, your Tuition Assistance application will not be processed.
- Awarded tuition assistance will not cover 100% of the tuition cost. The remaining costs are the responsibility of the applicant.
- Majority of Tuition Assistance & Scholarship awards will be determined by **June 20, 2025**.
