## SCHOLARSHIP & TUITION ASSISTANCE APPLICATION

Cathedral School maintains scholarship funds to recognize and support families who actively participate in the Superior Catholics parish cluster, or St. Francis Xavier, and who enroll their children at Cathedral School.

- Cathedral School awarded **\$45,000** in Scholarships & Tuition Assistance to our Kindergarten through 8th grade families in the 2025/2026 academic year.
- Cathedral School is committed to ensuring that no family is denied admission solely due to an inability to pay full tuition.
- Tuition assistance applications are available to families of all income levels and faith backgrounds. Awards are determined in accordance with established guidelines that assess demonstrated financial need.
- To be considered for tuition assistance or scholarship funding, families must complete and submit all required forms, including the K-8 Tuition Contract, SCRIP Agreement, and Youth Image & Recording forms.
- Family accounts must be in good standing at the time of application; applications from families with past-due balances or outstanding financial obligations will not be processed.
- Scholarships & Tuition Assistance awards do not cover the full cost of tuition. Any remaining balance is the responsibility of the applicant.

**TO APPLY:** Complete this application, front and back. Submit application with all required documentation (see below) to the main office in an envelope marked, ***Jaime Samarziya - Confidential***. Scholarship & Tuition Assistance awards will be determined by June 19, 2026, for applications submitted by **April 17, 2026**.

### REQUIRED DOCUMENTS:

- Pages 1 & 2 of your 1040 Tax Form from your 2025 Federal Tax return are REQUIRED for requests greater than \$200. (Requests of \$200 or less, requires completion of the application, but no Tax documents.)
  - If a married couple files separately, both incomes and both 1040 forms must be submitted.
  - If divorced, or married and filing separately, both parties are REQUIRED to submit pages 1 & 2 of their 1040 Tax Form of their 2025 Federal Tax returns.
